# Data Privacy Notice

## *Flintham & District Agricultural Society*

### **Your personal data – what is it?**

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation 2016/679 (the "GDPR").

### **Who are we?**

Flintham & District Agricultural Society is the data controller (via the General Secretary or [ploughing@flinthamshow.co.uk](mailto:ploughing@flinthamshow.co.uk)). This means it decides how your personal data is processed and for what purposes.

### **How do we process your personal data?**

Flintham & District Agricultural Society complies with its obligations under [the GDPR] by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.

We use your personal data for the following purposes:

- To administer records of exhibitors.
- To maintain our records and accounts.
- To fundraise and promote the activities of the Society, namely the staging of Flintham Ploughing Match & Agricultural Show and its associated activities.

### **Sharing your personal data**

Your personal data will be treated as strictly confidential and will not be shared with any third party, other than in any response to any government agency enquiry concerned with Health & Safety and Food Hygiene.

### **How long do we keep your personal data?**

We keep your personal data for no longer than reasonably necessary – for a period of five years during which time it is considered you may be actively trading and therefore interested in future events.

### **Your rights and your personal data**

Unless subject to an exemption [under the GDPR], you have the following rights with respect to your personal data: –

- The right to request a copy of your personal data which the Flintham & District Agricultural Society holds about you;
- The right to request that the corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for Flintham & District Agricultural Society to retain such data;
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to lodge a complaint with the Information Commissioners Office.
